3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The program has been granted accreditation for further 3 years. **Rajalakshmi Institute of Technology, Kuthambakkam Post, Chennai 600 124, Tamil Nadu** has been conferred autonomous status from the academic year 2023-24 and should submit fresh online application through eNBA portal under Tier I document not before five months from the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Rajalakshmi Institute of Technology, Kuthambakkam Post, Chennai 600 124, Tamil Nadu** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
